Action Items	<p>Patrick provided an update on the Emergency Management Plan Annexes under revision. Drafts can be accessed at https://gcem.myqnapcloud.com/share.cgi?ssid=0lwaaTj</p> <ul style="list-style-type: none"> Shelter and Mass Care revisions largely consist of updating terms from VOAD or COAD and removing the Medical Reserve Corp. Evacuation revisions consist of making sure we reflect the MSPOA recommendations and incorporating Shelter in Place into the annex. References to the Duties of a Fire Chief in regards to evacuation has been added. Health and Medical Services and Human Services updates consist largely of grammatical edits. The Health Department and EM and meeting to go through them in more depth. <ul style="list-style-type: none"> Patrick provided a quick summary of the State Preparedness Report. The form got submitted accidentally which prevented others from seeing it. Concerns exist on the validity of how this information is collected and whether it accurately reflects anything. Patrick took a general approach of middle high with nothing having full capacity. No one present had any issues with the draft rankings.
Updates	<ul style="list-style-type: none"> The Violent Attack Subcommittee hasn't met the past couple months. Now that fire season is over the group will be getting back together. The group started off following a FEMA template, but feel that with NFPA 3000 now being out that it may be a better template to follow. There was also discussion about the group name and if it should be changed to Active Killer or the term used in NFPA 3000. A working group has also been established with Sean Grabbe as the facilitator to work on training and equipment standards.

	<ul style="list-style-type: none"> • Gallatin County has received the award for the Mass Casualty Incident grant. However FEMA has flagged the County's Cognizant Agent Agreement and the indirect rate funding in frozen until that is resolved. • What used to be the Gallatin County Volunteer Organizations Active in Disaster has been reinvigorated and transformed into the Southwest Montana Community Organizations Active in Disaster. The group now covers Park, Gallatin and Madison Counties. They are independently organized, meeting monthly and cleaning up some functional holes. • Emergency Management will be advertising for the Operations and Training Manager in the near future with the intent of filling the position for a calendar year start. • Betty provided an update on the Unified Health Committee's recent table top exercise. They conducted an exercise on a long term pandemic and how that would affect local facilities. A major discussion was about when coordination was not enough and the system would need an ICS structure with assigned personnel to manage activities. UHC will be discussing this function in future sessions. • The NWS provided an update on long range weather. The current forecast is for warmer and dryer than normal winter. However there is some discussion that in this area the current long range components often lead to a warmer, but wetter winter than normal.
